

**COMMISSIONERS' PUBLIC MEETING**  
**October 1, 2009**

The Armstrong County Board of Commissioners' Public Meeting was called to order on Thursday, October 1, 2009 at 1:30 PM in the Commissioners' Conference Room with the following in attendance: Commissioners Patricia L. Kirkpatrick, Rich L. Fink and James V. Scahill, George J. Ms. Kirkpatrick announced that this meeting is being recorded.

**APPROVAL OF MINUTES**

On a motion by Mr. Scahill, seconded by Mr. Fink, and carried unanimously, the minutes for the September 23, 2009 Public Meeting were approved.

**CONTRACTS / AGREEMENTS**

**Hazardous Materials Flow Study Agreement**

On a motion by Mr. Scahill, seconded by Mr. Fink and carried unanimously, based on the recommendation of Mr. Cappel, and the review of the county solicitor, the County Commissioners acknowledged the Hazardous Materials Flow Study Agreement between Armstrong County and JH Consulting. Mr. Cappel stated that JH Consulting, a West Virginia company, will perform a study of the transportation of hazardous materials over the county's roadways. The study will be completed by August 31, 2010 at a total cost of \$4,850.00, the county will only be responsible to pay \$970.00, a twenty percent soft match, and the remainder will be paid from HazMat funds.

**PROCLAMATIONS**

**Domestic Violence Awareness Month**

Ms. Johns expressed appreciation to the Board of Commissioners for their support. She stated that HAVIN provided services for over 750 clients in the last fiscal year. Ms. Johns reminded everyone that services are available to men and women, stating that last year approximately twenty percent of their services were provided to men. She stated that HAVIN is "holding their own", despite the state budget impasse, but they are anxiously awaiting a resolution.

Ms. Kirkpatrick read aloud the proclamation.

On a motion by Mr. Fink, seconded by Mr. Scahill and carried unanimously, the County Commissioners proclaimed October as Domestic Violence Awareness Month. The Board of Commissioners commended HAVIN for the work that they perform and the services that remain to be offered at no cost to the recipient. Ms. Johns invited everyone to attend HAVIN's annual

fundraiser that will be held October 23, 2009 at Lindgrow Farms; the event will include a silent auction.

#### Eleanor "Dolly" Barrett Day Proclamation

Deputy Tarr stated that his mother-in-law is an amazing lady, and that it seems unbelievable that she is celebrating her 100<sup>th</sup> birthday.

Mr. Scahill read aloud the proclamation.

On a motion by Mr. Scahill, seconded by Mr. Fink and carried unanimously, the County Commissioners proclaimed October 5<sup>th</sup> as Eleanor "Dolly" Barrett Day. The Board found Mrs. Barrett's life to be filled with many interesting facts, most notably her extremely small birth weight of two pounds four ounces, her family relationship to General Neville, and her time spent as an employee of Armstrong County.

### **BOARD APPOINTMENTS**

#### Off Highway Vehicle (OHV) Steering Committee Appointments

Ms. Conklin stated the County has received funding from Department of Conservation and Natural Resources to conduct an OHV feasibility study. The steering committee will meet a few times over the next three months.

On a motion by Mr. Fink, seconded by Mr. Scahill and carried unanimously, the County Commissioners approved the six following appointments to the Off Highway Vehicle (OHV) Steering Committee:

### **OTHER BUSINESS / PUBLIC COMMENT**

#### Financial Transactions

On a motion by Mr. Fink, seconded by Mr. Scahill and carried unanimously, the County Commissioners acknowledged the approval of financial transactions for September 2009.

Mr. Fink extended his best wishes to Mrs. Barrett and family; he made a special reference to the close relationship that their family is fortunate to share. He stated that we are blessed to have residents who have given so much to the county. He also expressed how fortunate we are to have HAVIN in Armstrong County. He commended them for their resilience in facing the obstacles present by the state budget impasse. Mr. Fink discussed the press release by the Governor that was scheduled to start at 1:30, stating that the legislators' actions are disgraceful. He passionately implored citizens to contact their legislators and hold them accountable for their actions. He closed his statements by praising the work that has been done on the OHV Trails. He stated he feels that the steering committee's input and the completion of the trails will bring a positive effect to tourism in the county.

Mr. Scahill expressed his support for the Hazardous Materials Flow Study, describing it as critical to the safety of our roadways. He noted the increased usage of the 422 corridor as justification to the importance of the study. He then proclaimed that "Tough Guys Wear Pink"! Mr. Scahill referenced his pink shirt that he wore in tribute to Breast Cancer Survivors, particularly his wife, and that he also honors all who have lost their battle with cancer. He encouraged everyone to show their support throughout the year, but especially during October, the official month for Breast Cancer Awareness.

Ms. Kirkpatrick commended Joellen and the staff of HAVIN for their efforts in, what she knows is, a difficult job. She expressed delighted surprise that Mrs. Barrett is still interested in reading at age 100, stating that she hopes to still possess her love of reading at that age. Ms. Kirkpatrick praised the rapid progression of the OHV Plan, that it is "the people's plan". She noted that the work has been continuous, crediting the volunteers for their interest and time spent. She anticipated the successful results of their plan. Ms. Kirkpatrick expressed disappointment at the continuance of the state budget impasse. She described the Southwestern Pennsylvania Commission meeting that the Board attended at the beginning of the week. At the meeting an overview of the cuts in the proposed state budget was made available. She noted the substantial supporting data that displays the distressful effects that the budget cuts have made. Ms. Kirkpatrick is hopeful that the Governor and Legislators will realize the importance of supporting Economic Development in Pennsylvania.

Ms. Simon addressed the Board of Commissioners with concerns regarding the transfer of property she and her husband purchased in Armstrong County. The Board stated that they are aware of the situation and have referred the matter to the county solicitor. They assured Ms. Simon of their desire to assist in expediting the process and resolving the issue.
