Making Selections



1. TO VOTE YOU MUST COMPLETELY BLACKEN THE OVAL TO THE RIGHT OF YOUR CHOICE. An oval darkened indicates a vote for that candidate. Do not select more candidates than permitted in each race.


2. To cast a write-in vote for a person whose name is not on the ballot, blacken the oval beside the “Write-in” line and write his/her name legibly in the space provided.

3. If you spoil your ballot, DO NOT ERASE OR CROSS OUT, request a new ballot.
